Section GC – Professional Staff

Note: Unlike teachers employed by school districts, teachers employed by a BOCES are not protected by the Teacher Employment, Compensation and Dismissal Act of 1990, C.R.S. 22-63-101 et seq. The policies in this section “GC” pertaining to professional staff take the approach that all professional staff are “at will” and, therefore, may be terminated at any time for any legally permissible reason. CASB strongly encourages the BOCES to consult with its attorney to ensure that the BOCES’s interests are protected in this area and that the BOCES’s employment practices are consistent with the assertion that BOCES’s professional staff are “at will.”
